

(The Registration of Foreigners Rules, 1940 (hereinafter in this Order referred to as the Rules))

No. 11.- In exercise of the power conferred by section 6 of the Registration of Foreigners Ordinance, 1940 (Ordinance No. 1 of 1940), the Governor makes the Declarations hereinafter set out in this Order:-

Exemption Order No.1 under Ordinance No. 1 of 1940.

1. The provisions of the Registration of Foreigners Rules, 1940 (hereinafter in this Order referred to as the Rules) shall not apply to, or in relation to, any person who proves to the satisfaction of the Registration Officer that he has not attained the age of sixteen years.
2. The provisions of the Rules shall not apply to any vessel travelling solely between ports or places in British Burma or to, or in relation to, any person travelling in any such vessel.
3. The provisions of the Rules, except rule 8 and such of the provisions of rules 4, 14, 15 and 16 as apply to, or in relation to passengers and visitors who are not foreigners, shall not apply to, or in relation to.-
 - (a) any foreigner in the service of His Majesty;
 - (b) any British protected person;
 - (c) the wife and any child of-
 - (i) any person duly appointed by a foreign Government to exercise diplomatic functions, or
 - (ii) any consul or vice-consul;
 - (d) any native of French or Portuguese India;
 - (e) any person of Asiatic birth who is a subject of any State having sovereignty over any territory of which the boundaries are coterminous with the boundaries, external or internal of Burma; or
 - (f) any foreigner not specified in any of the preceding clauses of this Declaration who enters British Burma solely in transit to a destination beyond British Burma, for so long as he is authorised to travel in British Burma under a licence previously obtained by him from the Registration Officer of the place at which he enters British Burma and complies with such conditions as to route and other matters as may be specified in the said licence.
4. The provisions of rules 4, 15 and 16 of the Rules shall not apply to, or in relation to, any passenger to whom Declaration 3 of this Order applies and who enters, or departs from, British Burma on board any

vessel travelling solely between a port in British Burma and a port in India and Ceylon, French India, or Portuguese India.

5. Subject to the condition that he has obtained permission from the Registration Officer to land in British Burma, the provisions of the Rules except rules 8 and 14 shall not apply to, or in relation to, any passenger who arrives in British Burma on any vessel in transit to a destination beyond British Burma and who re-embarks and continues his journey on the vessel on which he arrived in British Burma.
6. The provisions of the Rules except rules 8 and 14 and sub-clause (d) of sub-rule (1) of rule 16 shall not apply, for so long as the vessel on which he is employed remains at a port in British Burma, to, or in relation to, any seaman as defined in the Rules who is not a resident of British Burma and does not land in British Burma for discharge.
