**(The Myanmar Wireless Telegraphy Licenc Charges Rules, 1960.)**

**NOTIFICATION No.147.**

**Rangoon, the 3rd November 1960.**

No.147. - In exercise of the powers conferred by sections 4 and 7 of the Myanmar Telegraph Act and section 10 of the Myanmar Wireless Telegraphy Act, the President of the Union Makes the following rules regarding the licence charges for establishment, maintenance and working of the wireless telegraphy apparatus:-

1. (1) These rules may be called the Myanmar Wireless Telegraphy Licenc Charges Rules, 1960.

(2) They shall be deemed to have come into force on the 1st January 1960.

2. In these rules, unless there is anything repugnant in the subject or context:-

(a) "amateur station licence" means a licence to establish and use the amateur service of self training, intercommunication and technical investigations carried on by amateurs, that is, by duly authorised persons interested in radio technique solely with a personal aim and without pecuniary interest;

(b) "model control licence" means licence to establish and use a station for wireless telegraphy for the purpose of controlling the movement of a model vehicle, vessel or aircraft, by means of the emission of electromagnetic energy from sending apparatus, and the reception of such energy by receiving apparatus in the model:

(c) "press receiving licence" means a licence to establish and use a receiving station for wireless telegraphy for the sole purpose of receiving press messages;

(d) "dealer" means any person who deals in or manufactures for gain wireless telegraphy apparatus as defined in the Myanmar Wireless Telegraphy Act.

3. Except amateur station licence, model control licence and press receiving licence, all other types and classes of wireless station licences shall be charged at the following rates; namely:-

4. Licence charges for amateur station licence model control licence and press receiving licence shall be k 10 per station per annum irrespective of antenna power.

5. Fees specified below shall be charged for the following types of licences; namely:-

6. On the issue of a licence, the licensee shall pay the full amount of the fee specified in relation to that type and description of licence, whatever may be the duration of the licence.

7. A licence shall continue in force for one year from the date of issue and thereafter so long as the licensee pays to the Licensing Authority in advance in each year on or before the anniversary of the date of initial issue, the fee specified in rules 3, 4 and 5.

8. No refund shall be ganted of any fees paid under these fulle ground of the inability of the licensee to make full use of Licence.
