No. 43.- Under section 13 of the Myanmar Naturalization Act and in supersession of the rules published with Political Department Notification No. 60, dated the 27th November 1926, as amended by General Department Notification No. 146, dated the 4th October 1927, the Governor makes the following rules:-

1. These Rules may be cited as the Myanmar Naturalization Rules, 1939.

2. A certificate of naturalization may be issued in Form A, B, C or D annexed to these rules.

3. A duplicate copy of the certificate, together with the application upon which the certificate was issued and the affidavit which accompanied the application, shall be recorded by the Secretary to the Government of Myanmar, Defence Department, who shall also keep an alphabetical list of all persons to whom certificates of naturalization have been issued in Myanmar.

4. A declaration under section 7 (1) of the Act by the wife of a man to whom a certificate of naturalization has been granted, shall be made in Form E annexed to these rules.

5. A declaration of alienage under section 10 of the Act shall be made in Form F annexed to these rules.

6. A declaration of alienage under section 10 of the Act or of acquisition of British Nationality by a wife under section 7 (1) of the Act may be made before any magistrate in Myanmar. The magistrate before whom such declaration is made shall forward it to the Secretary to the Government of Myanmar, Defence Department, for registration and record.

7. A certificate granted under section 12 (2) of the Act shall be in Form G annexed to these rules.

8. The oath of allegiance under section 6 of the Act and the copy of the certificate under section 12 (2) shall be recorded with the application and affidavit in the office of the Secretary to the Government of Myanmar, Defence Department.

9. The following fees shall be levied, viz:-

(1) The grant of a certificate of naturalization to a woman who was a British subject previously to her marriage to an alien and whose husband has died or whose marriage has been dissolved.	3 45
(2) The grant of a certificate of naturalization in other cases.	45
(3) For making a declaration of acquisition of British Nationality by a wife under section (7) 1 of the Act.	2
(4) For making a declaration of alienage under section 10 of the Act.	2
(5) For a certificate of administration of the oath of allegiance.	5
(6) For the registration of a declaration of acquisition of British Nationality by a wife under section (7) 1 of the Act.	4
(7) For the registration of a declaration of alienage under section 10 of the Act.	4
(8) For a certified copy of any declaration or certificate with or without oath.	8

Of the fee of Rs. 45 payable in respect of the grant of a certificate of naturalization Rs. 15 shall be payable on the submission of the application for a certificate, and shall in no circumstances be returned; the remaining Rs. 30 shall be payable on the receipt of the decision to grant a certificate.
